## JOEL CLARK

**Joel Clark and his wife Marley A.E. Clark settled in Pike County, Arkansas from Alabama. He was a Confederate soldier and apparently died during the Civil War on Mulberry Mountain, Arkansas.**

Joel Clark was born in South Carolina in 1810. His name initially appears in Pike County, Arkansas in the 1845 tax records. In these same records for 1857 his land is first described as: the S.W. quarter of the N.W. quarter of Section 6, Township 9 South, Range 24 West; the N.W. quarter of the S.W. quarter of Section 6, Township 9 South, Range 24 West; the S.E. quarter of the N.E. quarter of Section 1, Township 9 South, Range 25 West and the N.E. quarter of the S.E. quarter of Section 1, Township 9 South, Range 25 West comprising a total of 155.80 acres valued at \$475. This land is situated one mile north above the Little Missouri river and two and one half miles west-northwest of Billstown, Arkansas on High-way 301.

On May 17, 1858 Joel Clark purchased additional land (forty acres) from the Land Office at Washington, Arkansas described as: the N.E. quarter of the S.W. quarter of Section 26, Township 8 South, Range 25 West. This tract is located about two and one quarter miles west-northwest of the first lands described above and four miles from Murfreesboro. When the census was taken in Pike County, Arkansas in 1850 and 1860 Joel Clark's residence was in Missouri Township.

Joel Clark enlisted as a Private soldier in Company I, Morgan's Battalion, Arkansas Infantry (also designated as the 26th Regiment Arkansas Infantry) on October 8, 1862 at Camp Hope, Arkansas for the term of 3 years. The first company muster roll thereafter indicates Joel Clark is "absent sick on Mulberry Mountain, Arkansas October 24, 1862." The company muster roll for May and June 1863 states

"absent on Mulberry Mountain from October 26, 1862 supposed sick or dead." The Probate Court Estate Records of Pike County, Arkansas April Term 1866 (Burned Re-cords abstract) indicate Joel Clark is deceased.

Hazel Clark of Pampa, Texas writes about her husband's ancestor (1993) and says "nothing is known about him much, only he was born about 1810 in South Carolina somewhere, lived in Alabama a while, and moved to Pike County, Arkansas after 1840 and settled at Missouri Township. It is believed he came from Cherokee County, Alabama to Arkansas, no proof of this. All his children except Jim was born in Pike County, Arkansas."

The children of Joel Clark and his wife M.A.E. (Marley) \_\_\_\_\_, include: James or Jim T. Clark married Prudence \_\_\_\_\_, and moved to Crockett, Texas; John N. Clark; Sarah J. Clark; George Marshal Clark; W.A. Clark; S.F. Clark; and M.E. Clark.

In the 1860 census of Pike County, Arkansas Elizabeth Harris aged 65 of Georgia is living in the Joel Clark household. Her relationship to the Joel Clark family has not been determined. Hazel Clark writes "Elizabeth Harris - who is she living in Joel & M.A.E. Clark's home born in Georgia? Could she be the mother of Joel's wife or older sister of Joel or an aunt?" William L. Self, Pike County, Arkansas [June 10, 1901]. Nathan Kizzia [July 8, 1901] citizen of Pike County, Arkansas "well acquainted with applicant William L. Self and have known him 40 years." Mary P. Self, Stanley P.O., Pike County, Arkansas [March 13, 1916] ... "my husband died on the 28th day of February, 1916." Z.A. Copeland and J.E. Buckley [March 13, 1916] citizens of Pike County, Arkansas "well acquainted with applicant Mrs. Mary P. Self widow of William L. Self deceased, and have known her 15 and 55 years, respectively." Mary Parella Self, Murfreesboro, Pike County, Arkansas [February 17, 1932] born August 12, 1857, County of Pike, State of Arkansas ... married to William Locke Self on the 2nd day of March, 1873, County of Pike, State of Arkansas. She makes her home with her children, sons and daughters.

S.J. Sevier, Newhope, Pike County, Arkansas [widow] of James C. Sevier [June 26, 1916] ... "my husband died on the 17 day of December, 1915." Bessie Shankles and Effie Shankles [June 26, 1916] citizens of Newhope, Pike County, Arkansas "well acquainted with applicant S.J. Sevier and have know her 18 and 22 years, respectively."

Mary Sevier, Glenwood, Pike County, Arkansas [widow] of Peter C. Sevier [April 25, 1914] "her said husband the late Peter C. Sevier died while in the

service ... and in the line of duty at White Sulphur Springs near Pine Bluff, Arkansas on or about the 20th day of February, 1863." J.T. Dillard aged 73 years [June 6, 1914] ... address is Montesano, Chehalis County, State of Washington ... "well acquainted with applicant's husband, the late Peter C. Sevier, deceased, and knew him for the last past five years prior to his enlistment and enrollment as a private in Company E, 33 Regiment, Arkansas Volunteers on or about the 19 day of June, 1862; that he is now dead, and did not desert the service, but died while in the service in the line of his duty at White Sulphur Springs, near Pine Bluff, in Southeastern Arkansas, on or about the 14 day of February, 1863 and that his widow Mary Sevier, nee Dillard ... has been a bona fide resident of the State of Arkansas; that his knowledge of these facts comes from a five year acquaintance with the said Peter C. Sevier prior to his enlistment as aforesaid ... and a life-long acquaintance with his widow the said Mary Sevier, nee Dillard, and the applicant herein and that she has not since remarried." Louis F. Thompson aged 65 years, James C. Sevier aged 94 years, and Sarah J. Sevier, aged 82 years citizens of Pike County, Arkansas "well acquainted with applicant's husband Peter C. Sevier and knew him ... Louis F. Thompson, seven years and James C. and Sarah J. Sevier, all of their lives prior to the death of Peter C. Sevier on or about February 14, 1863. That our knowledge of these facts comes from a lifelong acquaintance with the said Peter C. Sevier and his widow Mary C. Sevier applicant herein ..." A.K. Clingman aged 65 years [May 25, 1914] a citizen of Pike County, Arkansas "well acquainted with applicant's husband Peter C. Sevier and knew him for the last past 13 years prior to his death on or about the 20 day of February, 1863."

M.F. Smalling, Kirby, Pike County, Arkansas [widow] of Wade H. Smalling, Sr. [July 8, 1909] aged 62 years ... "my said husband died on the 23 day of December 1907, at the residence of Wade H. Smalling, Jr. near Daisy, Pike County, Arkansas in Self Creek Township." James T. Gregory [July 8, 1909] "well acquainted with the late Wade H. Smalling Sr., deceased, and his various surroundings prior to, during and subsequent to the late civil war of 1861 to 1865, and up to the date of his death, December 23, 1907 ... and well acquainted with his surviving widow M.F. Smalling ... and have known her the last past 20 years." Jacob Johnson aged 65 years a citizen-resident

of ... Emerson, Columbia County, Arkansas ... "well acquainted with Wade H. Smalling Sr. and his various surroundings while then a resident of Caldwell Parish, State of Louisiana, prior to, during and subsequent to the late civil war, 1861 to 1865 ..."

L.J. Smith, Bills, Pike County, Arkansas [widow] of E.P. Smith [May 14, 1909] ... "my said husband died February 10th 1875." John T. Hipp [May 19, 1909] citizens of Bills, Pike County, Arkansas "well acquainted with applicant's husband E.P. Smith and knew him for about twelve years ... having associated with him during and after the service." Jesse Carroll [May 20, 1909] citizen of Clark County, Arkansas "well acquainted with applicant's husband E.P. Smith and have known him many years."

Robert Stafford [July 7, 1903] Newhope, Pike County, Arkansas ... member of 27 Alabama Regiment of Infantry, from the state of Alabama. D.J. Claunch and G.W. Kimbrough [June 15, 1901] citizens of Colbert County, Alabama "Well acquainted with applicant Robert Stafford and have known him forty years, respectively ... that he is about 70 years of age." M.E. Stafford, DeQueen, Sevier County, Arkansas [widow] of Robert Stafford [June 6, 1911] ... "my husband died on the 30th day of January 1911 caused ... from age." W.W. Waters and T.P. Smith [June 6, 1911] citizens of Sevier County, Arkansas "well acquainted with applicant's husband Robert Stafford and knew him for 6 years."

Mary F. Stewart, Murfreesboro, Pike County, Arkansas [widow] of William M. Stewart [June 28, 1901] ... "that my said husband died November 23, 1870." G.W. Brock [June 21, 1901] citizen of Bingen, Hempstead County, Arkansas "well acquainted with applicant Mary F. Steuart, widow of William Steuart, deceased, and have know her 40 years ... that he, William M. Steuart deceased ... belonged to Company G, 4th Arkansas Regiment of Infantry ... that as such soldier he served from August 1861 to March 1862 at which time he was wounded to such an extent as to render him unable for further service ... that she is the

widow of William M. Steuart, deceased, soldier aforesaid." See also Mary F. Stuart [640] widow of William M. Stuart.

R.W. Stough, Rock Creek, Pike County, Arkansas [June 5, 1906] ... "I am now 72 years old." J.T. Power [June 5, 1906] citizen of Pike County, Arkansas "well acquainted with applicant R.W. Stough and have know him 45 years." Amanda Stough, Pike County, Arkansas [widow] of R.W. Stough [April 26, 1911] ... "my husband died on the fourth day of December, 1910." Mrs. Amanda Stough, Glenwood, Pike County, Arkansas [February 15, 1932] born October 8, 1837, Tallapossa County, Alabama ... married to Mr. R.W. Stough, do not remember exact date, 1857, Tallapossa County, Alabama. She makes her home with D.C. Stough, Glenwood, Pike County, Arkansas "my son." Amanda Stough died August 4, 1932. M.D. Cummings, sheriff of Pike County, Arkansas public administrator.

John P. Stroope, Murfreesboro, Pike County, Arkansas [May 22, 1909] "being 64 years." O.S. Johnston [May 22, 1909] citizen of Pike County, Arkansas "well acquainted with applicant J.P. Stroope and have known him fifty years." Emma S. Stroope, Pike County, Arkansas [widow] of J.P. Stroope [July 5, 1910] ... "my said husband died on the 16th day of July, 1909." O.S. Johnston [July 5, 1910] citizen of Pike County, Arkansas "well acquainted with applicant's husband John P. Stroope and knew him for forty years."

Mary F. Stuart, Murfreesboro, Pike County, Arkansas [widow] of William M. Stuart [July 2, 1891] ... a soldier in the State of Arkansas ... Company G, 4th Regiment of Cornell [as spelled] McNare and continued in the service of the State of Arkansas or the Confederate States of America until the 7th day of March 1862 and he being in the service about eleven months was wounded from which wounds caused his death leaving Mary F. Stuart a widow." See Mary F. Stewart [8853] widow of William F. Stewart.

Mary E. Tallant, Murfreesboro, Pike County, Arkansas [widow] of M.R. Tallant [July 6, 1912] ... "my said husband died about December 1903." E.F. McClure and William D. Alford [July 6, 1912] citizens of Pike County, Arkansas "well acquainted with applicant's husband Marion Richard Tallant and knew him for sixty-eight years."

Leaner Tarpley, Pike County, Arkansas [widow] of G.W. Tarpley [June 16, 1903] ... "my said husband died 18 May 1897. M.L. Westerman [June 18, 1903] citizen of Bingen, Hempstead County, Arkansas "well acquainted with applicant's husband G.W. Tarpley and have known him fifty years." A.N. Hutchinson [June 16, 1903] citizen of Pike County, Arkansas "well acquainted with applicant's husband G.W. Tarpley and knew him 34 years."

"my said husband died January 11th 1913." John C.C. French and Samuel T. East [May 31, 1913] citizens of Pike County, Arkansas "well acquainted with applicant's husband C.C. Tate and knew him for fifty years." Mrs. Nancy Tate died December 5, 1929. M.D. Cummings, sheriff of Pike County, Arkansas public administrator.

Taylor prior to, during and subsequent to the late civil war of 1861 to 1865." C.J. Taylor aged 71 years, Pike County, Arkansas [widow]

of John N. Taylor ... "my husband died on the 27 day of March 1913 at his home in Pike County, Arkansas.

W.P. Taylor, Kirby, Pike County, Arkansas [May 16, 1908] "now 63 years of age." G.C. Smith aged 72 years and Francis Smith aged 69 years [June 15, 1908] citizens of Pike County, Arkansas ... "well acquainted with applicant William P. Taylor and have know him fifty-two years, respectively. Nannie E. Taylor, Amity, Clark County, Arkansas [widow] of W.P. Taylor [February 13, 1932] born October 4, 1849, Merry Weather [as spelled] County, Georgia ... married to W.P. Taylor on the 15th day of October, year of 1874, County of Merry Weather, State of Georgia. She makes her home with her son-in-law Mr. J.E. McWha (he is a poor man), Amity, Arkansas. She has lived continuously in Arkansas for the past ... 54 years." Mrs. Nannie Taylor died December 12, 1932. W.T. Tolleson, Clark County, Arkansas sheriff, public administrator.

Nancy A. Adams [widow] of Eli Thompson [June 22, 1917] affidavit: State of Arkansas, County of Pike, ss: I, Nancy A. Adams, nee Cox, aged 79 years ... was born at Giles County, Tennessee on the 27 day of May, 1836, that I was formerly the wife and widow of Eli Thompson, deceased ... and for the last past 46 years have been a bona fide resident of this State, except the years 1911 and 1912 visiting my brother and sister in Texas, and the years 1913, 1914, 1915, and 1916 visiting my son Ola Thompson in Colorado ... that my said husband Eli Thompson died at his home near Kirby, Pike County, Arkansas on or about the 1 day of March, 1886; that on or about February 1887, I was married to one A.J. Adams, who deserted me and our home in 1891, that I have no knowledge of him, his whereabouts or destiny since that time, now 26 years ago, that he is supposed to be dead, that I have not since remarried." [Marriage Certificate] certified copy. Eli Thompson to Nancy Ann Cox. State of Mississippi, Itawamba County ... In virtue hereof the rights of Matrimony between Eli Thompson and Nancy Ann Cox were duly celebrated by me the 17th day of November 1859. Christopher Deavems, O.M.G. The above is a true copy of the original. Eli Phillips, Clerk. Book 5, page 202. J.H. Faulkner, now aged 68 years, resident of ... Daisy, Pike County,

Arkansas ... "well and intimately acquainted with Eli Thompson during his lifetime and his then wife, Nancy A. Thompson, nee Cox, and their various surroundings from the year 1874 up to the date of death of the said Eli Thompson in the spring of the year 1886, or 12 years prior to his death ... he knew the claimant herein, Nancy A. Adams as the widow of the said Eli Thompson, up to the day of her remarriage to one A.J. Adams in the spring of the year 1887, and that the said A.J. Adams deserted her and their home sometime during the year 1891 and that they have not resumed marriage relations since, and that he has not heard anything of, nor has he any knowledge of the whereabouts of the said A.J. Adams for the last past 26 years; that the said Nancy A. Adams, the claimant herein, and formerly the widow of the said Eli Thompson, is still living and has not remarried since her marriage to the said A.J. Adams in the year 1887, and that she resides near to Daisy, Pike County, Arkansas." James C. Yeargan, now aged 50 years [June 22, 1917] resident of ... Daisy, Pike County, Arkansas ... "well acquainted with Eli Thompson and his then wife, Nancy A. Thompson, for two years prior to the date of death of the said Eli Thompson in the spring of the year 1886 ... that he knew the said Nancy A. Thompson ... as the widow of the said Eli Thompson up to her remarriage in the spring of the year 1887 to one A.J. Adams, who deserted her and their home sometime during the year 1891 ... that they have not since resumed marriage relations ... whereabouts and destiny of the said A.J. Adams has been unknown to him ... for the last 26 years; and that she has not remarried, and is still living and resides in Self Creek Township, Pike County, Arkansas." James C. Yeargan now aged 50 years and J.H. Faulkner, aged 68 years, citizens of Pike County, Arkansas [June 22, 1917] "well acquainted with applicant Mrs. Nancy A. Adams, formerly the widow of Eli Thompson, deceased, and have known her 33 and 43 years, respectively."

1834. Josephine E. Thrash [widow] of D.M. Thrash [March 15, 1934] born February 17, 1853 ... "my husband died February 22, 1934." W.I. Meeks [March 15, 1934] citizen of Glenwood, Pike County, Arkansas "well acquainted with applicant and have known her for the past ten years ... she is the widow of D.M. Thrash who died on the 22nd day of February, 1934." Josephine E. Thrash, Glenwood, Arkansas [March 15, 1834] born February 17, 1853, Harris County, Georgia ... married to D.M. Thrash on the 8 day of February 1871, County of Merriwether, State of Georgia. She makes her home with B.P. Thrash, Glenwood, Arkansas [son]. Josephine E. Thrash died August 14, 1938, Pike County, Arkansas. P.G. Coker sheriff, public administrator.

Taylor age 66 [June 23, 1911] citizen of Pike County, Arkansas "well acquainted with applicant Tyrrel H. Thrash and knew him for the last past 40 or 50 years or more." James M. Williams aged 76 years, a citizen of Bingen, Hempstead County, Arkansas "well acquainted with applicant Tyrrell H. Thrash and have known him for the last past 50 years or more." Susan E. Thrash [widow] of Tyrrell H. Thrash [June 16, 1917] ... "my husband died on the 8th day of January, 1917." R.T. and A.B. Adams [June 16, 1917] citizens of Howard County, Arkansas "well acquainted with applicant Mrs. Susan E. Thrash and have known her nineteen years, respectively." S.E. Thrash, Pike County, Arkansas ... born the 16th day of January 1851 ... I am the widow of Terrall H. Thrash ... my husband died on the 8 day of January, 1917." A.C. Cowart and S.G. Ward [July 9, 1918] Pike County, Arkansas "well acquainted with applicant S.E. Thrash and have known her 20 years, respectively." Susan E. Thrash, Amity, Arkansas [February 16, 1932] born January 16, 1851, Merryweather [as spelled] County, Georgia ... married to T.H. Thrash on the 20 day of June, 1867, County of Merry Weather [as spelled], State of Georgia. She makes her home with her son-in-law J.H. Self, Amity, Arkansas. A.N. Shaw, Clark County, Arkansas County Clerk ... [June 6, 1934] ... that the application of the said Susan E. Thrash was transferred from Pike County, Arkansas; that said Susan E. Thrash died on or about the 24 day of May, 1934.

Mary C. Threlkeld, Delight, Pike County, Arkansas [widow] of R.P. Threlkeld [July 10, 1915] ... "my husband died April 22, 1898." Affidavit of John C. Wilson [July 9, 1915] Pike County, Arkansas. J.C. Wilson states on oath "that he is a resident of Pike County, Arkansas that he is Sixty-nine years old and has resided in said county and state for the greater part of his life; that on or about the first day of April 1864, he enlisted as a soldier in Company K, 5th Arkansas Cavalry, Confederate States Army and remained in said army until the close of the war, when he was honorably discharged and that he is now enrolled as a Confederate Pensioner of this state. Affiant further states that after the close of the Civil War he became well acquainted with the late R.P. Threlkeld ... that he knew him before and after his marriage to Mrs. Mary C. Threlkeld, who now survives him and has not remarried and now living in the Town of Delight in Pike County, Arkansas. Affiant further states that after the said R.P. Threlkeld was married to Mrs. Mary C. Threlkeld (whose maiden name was Mary C. Wilson) that they lived together as husband and wife for more than fifteen years within one half mile of affiant's home and was so living together at the time of the death of the said R.P. Threlkeld on the 22nd day of April 1898. Affiant states that he attended the bedside of the said R.P. Threlkeld during his last illness and was present when he died ... Affiant further states that during his extended acquaintance with the said R.P. Threlkeld he found him to be an honest, upright and Christian Gentleman and that he is as firmly convinced of his faithful service to the Confederate States as if they had actually served together." [signed] J.C. Wilson. Affidavit of S.B. Wall [July 10, 1915] Pike County, Arkansas. S.B. Wall states on oath "that he is a resident of Pike County, Arkansas; that he is Seventy-seven years of age and has resided in said county and state for the great part of his life ... affiant further states that after the war he became well acquainted with the late R.P. Threlkeld ... that he knew him before and after his marriage to Mrs. Mary C. Threlkeld who now survives him and who resides in the Town of Delight in Pike County [Arkansas] which has been her home practically ever since the said R.P. Threlkeld's death; that he was present when the said R.P. Threlkeld was married to Mrs. Mary C. Threlkeld on the 12th day of August 1881, that he was their family physician during their entire married life and attended the said R.P. Threlkeld during his last illness and was present when he died on the 22nd day of April 1898, and that to his own knowledge the said Mrs.

Mary C. Threlkeld has not remarried since the death of the said R.P. Threlkeld ... Affiant further states that during his extended and intimate acquaintance with the said R.P. Threlkeld he found him to be honest and upright and of unquestionable integrity and that he is as firmly convinced of his faithful service to the Confederacy as if they had actually served together in said Confederate States Army." [signed] S.B. Wall. Affidavit of M.K. Brock [July 10, 1915]. M.K. Brock [July 10, 1915] Pike County, Arkansas. M.K. Brock states on oath "that he is 74 years of age that he is a resident of this state and has continually resided in this state for a period of more than sixty years, and that he has spent the most of his residence in Pike County. That on the 1st day of July 1861 he enlisted in Company G, 4th Arkansas Infantry, Confederate States Army and that he remained in the service of said army until the close of the Civil War. Affiant further states that after the close of the Civil War he became well acquainted with the late R.P. Threlkeld ... that he knew him before and after his marriage to Mrs. Mary C. Threlkeld, who still survives him and now resides in the town of Delight in Pike County where she has resided to the knowledge of the affiant the greater part of the time since the death of her husband, the said R.P. Threlkeld. The said Mrs. Mary C. Threlkeld's maiden name was Miss Mary C. Wilson and she has not remarried since the death of her husband. Affiant further states that for more than fifteen years just prior to his death the said R.P. Threlkeld and Mrs. Mary C. Threlkeld lived together as husband and wife in the same community as this affiant, and that the said R.P. Threlkeld was regarded as a man of unquestionable integrity; that during his acquaintance with the said R.P. Threlkeld, he has many times talked with him concerning his service in the Confederate State Army, and while the affiant did not actually serve with the said R.P. Threlkeld, from the conversation had with him relative to his service he was firmly convinced that the said R.P. Threlkeld did serve in the Confederate Army and that he did not desert the same." ## RESEARCH BREAKTHROUGH

### Polk Family

The following is from the microfilm records of the "Commission to the Five Civilized Tribes" or "Dawes Commission" that was formed in 1893 by the U.S. government to exchange lands of the five tribes for individual land allotments in Indian Territory (now Oklahoma). This information is taken from application file MCR 4650 and is for Taylor Polk (et. al.) son of Taylor Polk and Prudence Anderson who once lived in Pike County, Arkansas. MCR stands for "Mississippi Choctaw Rejected." The claim was based on the 14th Article of the Treaty of 1830 also known as the treaty of "Dancing Rabbit Creek." It was rejected because Taylor Polk and his child did not appear on any of the rolls of the Choctaw Nation nor did it appear they had been admitted by the Commission or any judgement of the United States Court.

---

### MCR 4560 Taylor Polk et. al

Taylor Polk appeared before the Commission at Atoka, Indian Territory (now Oklahoma) on June 4, 1900 and made application for himself and child as citizens of the Choctaw Nation. His testimony is represented by question and answer. These are excerpts. Taylor Polk being first duly sworn by Acting Chairman Bixby testified as follows:

Question: State your name? Answer: Taylor Polk.  
Question: What is your age? I was born in '39 (1839). He indicates his residence and postoffice

address as Davis, Indian Territory.

Question: Are you a Choctaw? Answer: That is what I have been taught and what I claim. Question: What is the name of your father? Answer: Taylor Polk. Question: Is he living? Answer: No sir. Question: Was he on the Choctaw roll? Answer: I don't think he was. Question: What is the name of your mother? Answer: Prudence Anderson. Question: Is she living? Answer: No sir. Question: Was she on the Choctaw rolls? Answer: I am not claiming it on my mother; it is on my father.

Question: Did you apply to the Dawes Commission in '96 (1896)? Answer: Yes sir. Question: Were you admitted or rejected? Answer: I was rejected but my mother had some Cherokee blood in her and I applied for citizenship in the Cherokee nation and was rejected there; I never applied in the Choctaw Nation. Question: What proportion of Choctaw blood do you claim? Answer: The evidence I am giving you is just what I have been taught from my father, and I suppose he was about a quarter.

Question: Are you married? Answer: Yes sir. Question: What was your wife's name before she was married? Answer: Her name was Mary Ann Petty. Question: What is the name of her father? Answer: James Petty. Answer: What was the name of your wife's mother? Answer: Phoebe Petty. Question: What are the names of your children under 21 years of age, unmarried? Answer: I have got but one, Bevly (Beverly) R. Polk. Question: Is there any additional statement in regard to your case that you desire to make? Answer: In putting in this claim couldn't I put in for my grand-children? I have

some grandchildren. Reply: No. Question by affiant: Will my children all have to appear in person that are over 21 years of age? Answer: Yes sir. Question: Is there any additional statement that you desire to make in regard to this case? Answer: I don't know; all I want is to put it before the people as near correct as I can. Any statement that would be right for me to make I would like to make.

---

DECISION (Excerpts)

In the matter of the application of Taylor Polk et. al. for identification as Mississippi Choctaws ... we find from the record in the case of Taylor Polk et. al. that on June 4, 1900 the said Taylor Polk appeared before the Commission at Atoka, Indian Territory and there made application for enrollment of himself and minor child, Bevely (Beverly) R. Polk, as citizens by blood of the Choctaw Nation. The principal applicant claims descent from Taylor Polk, an alleged one quarter blood Choctaw, who married Prudence Anderson, a white woman, and who are the parents of this applicant. The evidence offered in support of this application ... embraces the ex parte affidavits of William L. Byrd, James J. Fry, the joint ex parte affidavit of Manervia Anderson and Joseph Freeman, the ex parte affidavit of Jonas Frazier, and the joint ex parte affidavit of F.M. Shipp and Sarah D. Shipp.

The ex parte affidavit of William L. Byrd is simply to the effect that the principal applicant, with whom he is acquainted, very much resembles one Taylor Polk whom he knew in the Choctaw Nation, Indian Territory, when a small boy. The ex parte affidavit of James J. Fry is simply to the effect that he was acquainted with the applicant and his father Taylor Polk Sr. and his family in Montgomery County Arkansas between the years 1846 and 1854 and that Anderson Polk and Ellen Polk brother and sister of the principal applicant bore striking evidence of being possessed of Indian blood. By the joint ex parte affidavit of Manervia Anderson and Joseph Freeman, it is attempted to be shown that affiants were acquainted with the father and grandmother of the principal applicant, the latter of whom (grandmother) ... was named Mrs. Patsy Polk (nee Walker) at Doaksville, Indian Territory, and that said persons enjoyed all the rights and privileges of Choctaw Indians by blood and were recognized as such. By the ex parte affidavit of Jonas Frazier it is attempted to be shown that the affiant was

acquainted with one Patsy Polk (nee Walker) and her son Taylor Polk, grandmother and father of the principal applicant, near Doaksville, Choctaw Nation, between the years 1836 and 1844, and alleges that said persons were part Mississippi Choctaw Indians by blood. By the joint ex parte affidavit of F.M. Shipp and Sarah D. Shipp it is attempted to be shown that affiants were acquainted with the entire family of Taylor Polk, deceased, father of the principal applicant, in Pike County, Arkansas between the years 1857 and 1865 and know them to be part Mississippi Choctaw Indians by blood, and that affiants were present at the wedding of Taylor Polk Jr., the principal applicant herein, and his wife, Mary Ann Petty, on the 21st day of August, 1859.

There is nothing in these affidavits which in any way tends to show that any of the alleged Choctaw ancestors of the principal applicant were ever recognized by the Choctaw tribal authorities as members of the Choctaw tribe of Indians in the state of Mississippi, or that they ever complied or attempted to comply with the provisions of article fourteen of the treaty of 1830.

---

Pedigree (Excerpts)

Patsy Polk, nee Walker, claim Choctaw, name of husband not given; (son) Taylor Polk Sr., dead, claim Choctaw, married Prudence Anderson, dead, Cherokee.

Henry Anderson married Bettie Mitchel, 1/2 Cherokee; (son) James Anderson married Fannie Griffin, 1/2 Cherokee; (daughter) Prudence Anderson, dead, Cherokee, married Taylor Polk Sr., dead, claim Choctaw.

The preceding file offers the name of Patsy Walker as the mother of Taylor Polk husband of Prudence Anderson. In **Polk Family and Kinsmen** by William Harrison Polk, 1912, page 100, it says "Taylor Polk ... married Jency Walker a daughter of Alexander Walker of Kentucky." In **The Polks of North Carolina and Tennessee** by Mrs. Frank M. Angellotti, 1923-1924, and reprinted by the James K. Polk Memorial Association, page 20: "Taylor Polk born in North Carolina about 1780 died in Polk Co., Ark. 11 Dec. 1824 ... married 1 Nov. 1798 Jency Walker who died at 'The Wilds' in the Valley of the Ouachita, Ark., 3 Dec. 1814, daughter of Tandy."

LETTER

My father's name was Taylor Polk. My mother's maiden name was Jincy Walker. Their first born was a boy his name was Ben, the second a boy Taylor, the third a boy, Jim, the fourth a boy Cumberland, fifth a girl Patsy, the sixth a boy William, seventh girl Jincy, eight a boy Alfred. My father Taylor Polk's second wife's name was Polly Warren, their first child a girl was Nelly, second a boy Washington, third Warnell.

My father had three Bros. John, Charley and William. One sister Ellen.

This brief letter (no date) was dictated by Jency (Polk) Anderson the daughter of Taylor Polk Sr. and Jency Walker to send to Mrs. Emma Angellotti, but was never mailed. It is now in possession of one of her descendants, E. Redell Cobb. Jency (Polk) Anderson was born February 1808 or 1810 and died May 12, 1903 at Cheyenne, Roger Mills, Indian Territory, Oklahoma. She married Mitchel Anderson.
