CLEMENT DAVIS

Clement Davis was born in Illinois on April 7, 1813 a son of Jeremiah and Stacia Davis. His parents came to Arkansas about 1820 to the three forks settlement of the Little Missouri river now Murfreesboro where Jeremiah Davis died in 1822. He was survived by six children, son Clement Davis and daughters Nancy, Rachel, Lydia, Isafena and Syrena. Stacia Davis appears to have re-married by 1824. She is referred to by the name of Stacy "Right" or Wright in the minutes of the Clark County, Arkansas Circuit Court, March Term 1824, where she is the administratrix of the estate of her late husband. In court records for 1825, 1826 and 1828 she is identified as Stacia Davis and in subsequent records throughout her life although there is a marriage of Stacy Davis to Richard Linville in Clark County, Arkansas on January 29, 1832. Stacia Davis had another son John Millard Davis born September 7, 1827 whose father is not known. John M. Davis would later become Sheriff of Pike County, Arkansas.

In 1833 Clement Davis made an improvement on land in a then unsurveyed township of Pike County. Surveyed in 1837 it revealed his improvement to be in Section 17 of Township 8, South of Range 25, West, and in the Northeast quarter. When the sale of public lands in this township were offered through the land office at Washington, Arkansas he purchased this entire quarter section in 1839.

Clement Davis married Mary Safronia Hancock about 1836 in Pike County, Arkansas. She came to Arkansas from Jackson County, Tennessee about 1831 and is indicated as a charter member of the Antioch Church of Christ established in 1833 at Delight, Arkansas according to church records. The

children of Clement Davis and Mary Safronia Hancock were:

Emily A. Davis born July 2, 1838 at Murfreesboro, Thompson Township, Pike County, Arkansas; death date unknown; buried in Davis Cemetery at Umpire, Arkansas.

Nancy Eveline Davis born March 2, 1841 at Murfreesboro, Thompson Township, Pike County, Arkansas; married John S. Hobson; died October 31, 1912; buried in Davis Cemetery at Umpire, Arkansas.

Isabel Safronia Davis born July 12, 1843 at Murfreesboro, Thompson Township, Pike County, Arkansas; married Robert Moore; death date unknown; buried in Davis Cemetery at Umpire, Arkansas.

Martha M. Elizabeth Davis born September 23, 1845 at Murfreesboro, Thompson Township, Pike County, Arkansas; married first Frank Givens; married second John Dalrymple.

Lydia Luricy (Lurisa) Emeline Davis born January 23, 1850 in Sulpher Springs Township, Polk now Howard County, Arkansas; married Jim Dalrymple; died June 6, 1882; buried in Davis Cemetery at Umpire, Arkansas.

Syrena Rebecca Elethe Davis born February 2, 1852 in Sulpher Springs Township, Polk now Howard County, Arkansas; married James K. Polk Miller; died November 1892.

Farris Bernard Hempstead Davis born August 24, 1857 in Sulpher Springs Township, Polk now Howard County, Arkansas; married Lualice Delona Miller on July 17, 1879 near Athens, Arkansas; died May 1, 1948; buried in Davis Cemetery at Umpire, Arkansas.

Clement Davis moved to Polk County, Arkansas and Sulpher Springs township about 1849 and entered land along the west bank of the Saline River approximately four miles southeast of the Umpire community now in north Howard County, Arkansas. He died in 1870 and is buried in the Davis Cemetery at Umpire. His epitaph, "Kind fa-ther of love, thou art gone to thy rest forever, to bask mid the joys of the blest." His wife Mary Safronia Hancock Davis

born August 20, 1814 in Tennessee died January 18, 1888 and is also bur-ied in the Davis Cemetery near her husband. Her epitaph, "Rest mother, rest in quiet sleep, while in sorrow o'er thee weep." Buried between them ac-cording to relatives are grandchildren who died of influenza.

PREEMPTION PROOF

Be it remembered, that on the twentieth day of May in the year 1839, Clement Davis of Pike County in the State of Arkansas personally came before me, the undersigned, a Justice of the Peace within and for the County of Hempstead in the State, aforesaid, at Washington in the County of Hempstead, aforesaid, in the presence of the Register and Receiver of the Land office at Washington, Arkansas and being duly sworn, states on his oath:

That, he is over twenty one years of age, to wit, about twenty six years of age, a married man, the head of a family con-sisting of his wife and one child; that in the year Eighteen hundred and thirty three he cultivated a portion of the Lands of the United States in a then unsurveyed Township, and that the Township was surveyed in the year 1837 and said im-provement was found to be upon the North East quarter of Section seventeen in Township Eight South of Range twenty five west in the District of Lands subject to sale at Wash-ington, Arkansas, and that in said year he cultivated on said tract, about eighteen acres, principally in corn and that he resided on said tract and had possession of the same on the nineteenth day of June, Eighteen hundred and thirty four and that he still resides on, has possession of, and cultivates the same.

Last Will and Testament of Clement Davis

In the name of God, Amen.

I, Clement Davis, in view of the uncertainty of life and the certainty of Death and being in my right mind, do make and cause to be made, this, my Last Will and testament, revoking all former Wills and testaments heretofore made.

First, I give and bequeath to my beloved Wife, Mary S. Davis, the use and control of all my real Estate and personal property

during her natural life except such property hereafter named in this will as gifts to the part(i)es named below.

Second, I give my daughter Martha M.E. Givenes (Givens) one horse Saddle and bridle, one cow and calf, out of my property after my death.

Third, I give to my daughter Sirena R.E. Davis one horse Saddle and bridle, one cow and calf, out of my property after my Death.

Fourth, I give to my son Farris B.H. Davis one horse Saddle and bridle, one cow and calf, and at the Death of my Wife and his Mother, all my Land Known and described as fowlers (follows) and being in the Washington Land district, Polk County, State of Arkansas: the NW Quarter of the SE Quarter of Sec. 18 in T. 6S R. 28W containing forty acres; SE of SE of 18, T. 6S R. 28W forty acres; also SE of SW of 18 T. 6S R. 28W forty acres; also SE of the SW of 18, T. 6S R. 28W forty acres; als(o) the SW of the SE of 18, T. 6S R. 28W forty acres; also the SW of the SW of 18, T. 6S R. 28W; also the NW of the NE of Sec. 19, T. 6S R. 28W, containing in all two hundred and forty acres, the fourth cause of this Will is not to take Effect so far as the land is concerned untill (sp) after the death of my Wife, Mary S. Davis, the other part to take efect (sp) (at) my Death.

I, Clement Davis, declare the above to be my last Will and testament.

WILLIAM T. HANCOCK

William T. Hancock was born in Laurens District, South Carolina in 1797. About 1806 his parents moved to Tennessee and settled in Jackson County.

The early records of Laurens County, South Carolina combined with later census records of Jackson County, Tennessee evidences the father of William T. Hancock to be Clement Hancock of the 1800 Laurens County, South Carolina census. The grandfather was Clement Hancock. He was in the service during the Revolutionary War. He served as a Lieutenant beginning June 3, 1780 in Col. Casey's South Carolina Regiment and on May 17, 1781 was among those taken as prisoners by the British and sent on the schooner "Packhorse" and kept in close confinement until the last of July 1781. Paroled he went home and again entered the service under the command of Col. Joseph Hayes the first day of August, 1781. He served until his death at Hayes Station in Laurens County, South Carolina on November 19, 1781. The account of his death is found in "The History of South Carolina in the Revolution 1780-1783" by Edward McCrady, 1902:

It was on a fine morning a few days after the massacre at Cloud's Creek when at ten o'clock a party led on by one John Hood rode up to the station (Hayes) at full gallop and reaching the piazza of the house called out in a loud voice that none should fire from within or they would all be put to death. Disregarding this warning a shot was fired and one of the Tories was killed. Cuningham (Bloody Bill) arriving shortly afterwards, sent a flag with a written message de-manding instant surrender and promising if the Whig party surrendered to spare all lives, but declaring, it is claimed, that if they resisted and so caused the spilling of his men's blood, he would give them no quarter, but put them to death. Colonel Hayes trusting to receive a reenforcement before the station could be carried refused to surrender and answered "he would hold out to the last." Hayes and his party made a vigorous resistance which lasted for hours, but Cuningham at last succeeded in setting fire to the house, which was of wood, by means of ramrods wrapped round with tow dipped in pitch and thrown in a blazing state on the roof. Half suffocated, Hayes and his party surrendered at discretion. Cuningham immediately hanged Hayes and another man Daniel Williams on the pole of a fodder stack. Before they were dead the pole broke and Cuningham drawing his sword slew the half-strangled men with his own hand. This he justified himself in doing because of alleged cruelties by Hayes to women and children, and of the killing by Williams of a favorite follower of his, one Thomas Ellison. Being told of the presence of one Cook, who, it was charged he with Ritchie and Moore whipped his brother to death, Cuningham ordered him out from the rest and slew him with his sword. He then gave permission to his men to do as they pleased with the rest. And all who had rendered themselves obnoxious in any way to the Tories were slain without mercy. Each of his men singled out whomsoever he would and killed him forthwith. The execution took place about sunset. Only two of the party fell in the action, fourteen were deliberately cut to pieces after their surrender.

Their names and rank as given by Ramsay in "Revolution in South Carolina," Volume II, page 273, were as follows: Colonel Joseph Hayes, Captain Daniel Williams, Lieutenant Christopher Hardy, Lieutenant John Neil, Clement Hancock, Joseph Williams, Joseph Irby, Sr., Joseph Irby, Jr., John Milvin, James Feris, John Cook, Greaf Irby, Benjamin Goodman, Yancey Saxon. The "Royal Gazette" for December 8, 1781 gives two names not mentioned by Ramsay. They were probably those of the killed in action, Captains Owen and Leonard. Of his party Cuningham had one man killed and five wounded. At this place a monument stands in Laurens County, South Carolina in com-memoration of the American patriots killed that day. Clement Hancock was survived by his wife Isabella and children: Sally, Clement, James, John, William, and Joseph Hancock.

William T. Hancock married Elizabeth Dickson on February 1, 1821 in Jackson County, Tennessee. Their known children include:

John D. Hancock born 1825 in Jackson County, Tennessee; married Angeline Stringer daughter of Rice Stringer and Rachel Davis on October 5, 1851 in Pike County, Arkansas; died November 15, 1869. He was killed by William R. Brewer at Murfreesboro.

William J. Hancock born 1827 in Jackson County, Tennessee.

Abner Hancock born 1832 in then Clark, Pike County, Arkansas (1833); married, wife unknown; died prior April 23, 1855. He was survived by an infant son Robert J. Hancock.

Mary S. Hancock born 1835 at Murfreesboro, Thompson Township, Pike County, Arkansas; married first Thomas Jefferson Conway about 1853 in Pike County, Arkansas; married second James M. Evans about 1859 in Pike County, Arkansas.

Rebecca E. Hancock born 1837 at Murfreesboro, Thompson Township, Pike County, Arkansas; married Robert Fletcher Roberson son of Benjamin Jefferson Roberson and Nancy Messer about 1859 in Pike County, Arkansas.

William T. Hancock entered military service of the United States in the War of 1818 against the Seminole Indians. He enlisted January 31, 1818 at Camp Blount, Tennessee for the period of six months. He was a private soldier in James Rod-gers' company and at the end of a five month tour of service he was mustered out at Columbia, Tennessee. This was on June 30, 1818. William T. Hancock settled in Arkansas about 1831 and lived at or near

Murfreesboro until his death on Decem-ber 24, 1849. Elizabeth Dickson Hancock born 1803 in Tennessee died at Murfreesboro on Jan-uary 12, 1854.

BOUNTY LAND CLAIM

Form of Declaration to be Made
By the Widow of a Deceased
Officer or Soldier.

On this 14th day of May A.D. one thousand eight hundred and fifty one, personally appeared before me, Thomas J. Conway a Justice of the Peace duly authorized to administer oaths within and for the County and State aforesaid, Elizabeth Hancock aged 47 years, a resident of Pike County in the State of Arkansas who, being duly sworn according to law, declares that she is the widow of William Hancock deceased, who was a private in the Company commanded by Captain James Rodgers in a Regiment of T.V.M.G.M. in the war with the Seminole Indians, that her said husband, volunteered in the State of Tennessee for the term of, not known, and continued in actual service in said war for the term of five months and was honorably discharged at Columbia, Tenn. on the 30th day of June A.D. 1818 as will appear by the original Certificate of Discharge hereto attached and also the muster rolls of said Company.

She further states that she was married to the said William Hancock in Jackson Co., Tennessee on the first day of February A.D. 1821 by one Sam'l Dickson a Justice of the Peace and that her name before said marriage was Elizabeth Dickson that her said husband died in Pike County, Arkansas on the 23rd day of December A.D. 1849 and that she is still a widow.

She makes this declaration for the purpose of obtaining the bounty land to which she may be entitled under the "act passed September 28th, 1850."

This is to certify that William Hancock private in Capt. James Rodgers' company of T.V.M.G.M. has served a tour of five months as a Volunteer, on an expedition against the Seminole Indians; he carries with him the thanks & gratitude of his commanding officer and merits the applause of his country, and is hereby honorably discharged.

The military record of William Hancock indicates he mustered in as a private in Capt. Chism's Company, 1st Regiment, T.V.M.G.M. on January 31, 1818. He was attached to Capt. James Rodgers' Company as given in the certificate of discharge. The military record under Capt. Chism and discharge above both indicate he was discharged on June 30, 1818 at Columbia, Tennessee.

POWER OF ATTORNEY.

Sebastian my true and lawful Attorney, for me and in my name, to demand and receive from the Department of the Interior of the United States, the Certificate or Warrant, to which I am entitled for the Military services of my said husband, as set forth in the foregoing Declaration; and, for good and sufficient reasons, do hereby revoke and counter-mand any and all other powers of attorney or other authority that may have been heretofore given by me.

That he volunteered at Jackson County, Tennessee on or about the 1st of February 1818 for the term of six months and was honorably discharged at Columbia, Tennessee on or about the 1st of August 1818, by reason of the expiration of his term of service. He further states that Elizabeth Hancock who was the widow of the said William Hancock as aforesaid and the mother of the said Rebecca, has received for the services of the said William Hancock, Bounty Land Warrant No. (not recollected) for 80 acres which was legally disposed of previous to the death of the said Elizabeth, which death took place on the 12 day of January 1854. SION B. DICKSON

Sion Bradley Dickson was born in Tennessee about 1807 and with his father David Dickson came to Arkansas about 1825 or 1826. They set-tled west of

the "three forks" of the Little Missouri river now Murfreesboro in what was then Hempstead County later annexed into Pike County, Arkansas when it was formed in 1833. Sion Bradley Dickson married Nancy Davis daughter of Jeremiah and Stacia Davis about 1826. Nancy Davis was born October 7, 1806 in Christian County, Kentucky. Her parents moved from Kentucky to Illinois about 1808 and eventually located in the new Arkansas territory where they settled at the "three forks" of the Little Missouri. They were among its first settlers. Previously living here were the families of William Hughes and Oliver Brewer. The children of Sion Bradley Dickson and Nancy Davis were:

James Ashley Dickson born March 4, 1828 in then Clark, Pike County, Arkansas (1833); married Mary Susan Rice (or Price); died January 22, 1896 at Tolosa, Kaufman County, Texas.

Susanna A. Dickson born 1830 in then Clark, Pike County, Arkansas (1833); married first Thomas P. Brewer about 1846 in Pike County, Arkansas; married second Pleasant Adams on July 20, 1855 in Hopkins County, Texas; married third Benjamin Davis prior 1870; she is Susanna "Branch" in the 1920 Pike County, Arkansas census, "mother" of John B. Davis.

Frances Ann Dickson born 1832 in then Clark, Pike County, Arkansas (1833); married Thomas B. Crawford on July 28, 1853 in Hopkins County, Texas.

Phoebe Dickson born 1834 at Murfreesboro, Thompson Township, Pike County, Arkansas; married Wiley A. Moss, February 3, 1857 in Hopkins County, Texas.

John E. Dickson born 1836 at Murfreesboro, Thompson Township, Pike County, Arkansas; married Clarissa, maiden name unknown.

Sarena (Syrena) Dickson born 1838 at Murfreesboro, Thompson Township, Pike County, Arkansas.

Leanna (Lee) Dickson born April 15, 1841 at Murfreesboro, Thompson Township, Pike County, Arkansas; married J.E. Howard; died Dec. 20, 1901; buried in Cumby Cemetery at Cumby, Texas.

Grandison Delaney Royston Dickson born 1843 at Murfreesboro, Thompson Township, Pike County, Arkansas.

Lurana (Louranie) Dickson born May 1, 1845 at Murfreesboro, Thompson Township, Pike County, Arkansas; married Daniel R. Stringer about 1866 in Hopkins County, Texas; died September 3, 1883; buried in Cumby Cemetery at Cumby, Texas.

Ellar Ringold Dickson born September 8, 1847 at Murfreesboro, Thompson Township, Pike County, Arkansas; married first, wife unknown; married second Mary R. Weaver on July 1, 1875 in Hopkins County, Texas; died January 4,

1929 at Cumby, Hopkins County, Texas; buried in Cumby Cemetery at Cumby, Texas.

Malinda Adaline Dickson born 1850 at Murfreesboro, Thompson Township, Pike County, Arkansas; married William H.C. Lile on October 12, 1865 in Hopkins County, Texas.

In 1831 Sion B. Dickson purchased an improvement from his wife's mother Stacia Davis. It was situated within the southeast quarter of Section eight in Township 8, South of Range Twenty-five, West. In 1839 he purchased this quarter section of 160 acres from the government that included the improvement acquired from Stacia Davis and thereafter received a patent. His land joined the original tract selected by the Pike County commissioners in 1834 for the county seat of Murfreesboro on the north.

In 1851 Sion Bradley Dickson sold his land and improvements to Enoch Lockhart and left Pike County, Arkansas for Hopkins County, Texas. When the federal census of Hopkins County, Texas was taken in 1860 the Dicksons post office is identified as Retina. Ten years later according to the census schedule their post office is Miller Grove. At some time after 1870 Sion Bradley Dickson died in Hopkins County, Texas. A search of cemetery records of the county has failed to locate his place of burial and a tombstone. Nancy Dickson afterward made her home with a daughter Malinda Lile. She died June 18, 1884 and is buried in the Cumby Cemetery at Cumby, Texas. Her epitaph reads "Mother is not dead, but slepeth."

Oda Templeton Memories

I remember three of my great grandparents. I will begin with the Dickson family. My great grandmother Dickson, Nancy Davis, was a tall blue eyed woman with dark hair. I remember my great grandfather (Sion Bradley) Dickson too, but he died when I was quite young. They were the parents of my grandfather James Ashley Dickson.

My grandfather was born about 1829. He entered the Confederate Army as a medical doctor from Cumby then known as Black Jack Grove. He had

already become interested in preaching and after the war ended he gave up the practice of medicine to devote his time to preaching. He had a close friend Dr. Reeves who entered the army with him who continued his medical practice. They became separated after the war. This Dr. Reeves attended grandma Willis when Aunt (June) Garnet was born and learned that grandma was a daughter of his old friend James Ashley Dickson. This made him very happy. Dr. Reeves was also a preacher and later he performed the marriage ceremony for my parents.

My grandfather James Ashley Dickson owned a general store and a farm which he operated through the week. His weekends were spent riding horseback to outlying communities and preaching. He also preached for revival meetings through the summer months. My grandfather was the finest man I ever knew. He and grandmother tried to teach me the finer things of life.

Dickson the following described land, to wit: Five hundred and twenty acres of land described as follows: lying and being in the above mentioned State and County on the Lake Fork of the Sabine River, the survey made by virtue of the (headrite) certificate to David Shepherd by virtue of law, and bounded as follows:

Beginning at a post set in the South boundary line of a Survey in the name of James Riley No. 46, one post oak bears West 2/10 varas; one other post oak bears South 26 West 3 varas; running thence South 1507 varas to a post in the North boundary line of a Survey in the name of E. JAMES ASHLEY DICKSON

March 4, 1828 - January 22, 1896

James Ashley Dickson, the eldest son of Sion Bradley and Nancy Davis Dickson, was a noteworthy son of Hopkins County. He was born in Pike County, Arkansas and spent the first twenty three years of his life there. His father was a pioneer of Clark, now Pike County, and was employed in the acquisition and development of a virgin land.

Ashley's mother Nancy Davis was a religious woman and a devoted follower of Elijah Kelley of Pike County, a leading minister of the day. We cannot prove that she pledged her first son to the service of the Lord, but she and Ashley are reg-

istered as charter members of the Antioch Church of Christ in Delight, Arkansas a church established by Elijah Kelley in 1833. The Reverend Kelley and his brother William, also a minister, continued to teach and influence the youth for the ministry, for it became his consuming call in life, although he learned farming from his father and later engaged in merchandising, and hotel operation as well, in order to earn a living. He was a medical corpsman during the War between the States.

In addition to being a minister and a farmer and hotel operator, James Ashley Dickson reared a family with his wife Mary Susan Rice (or Price), of five sons and three daughters. He owned a farm near Cumby and a store and a small hotel. His weekends were devoted to preaching in Cumby and nearby rural churches and in holding revival meetings during the summer.

His granddaughter, Oda Templeton is quoted as saying he was "the finest man" she ever knew. She tells of his ministry in Llano, Texas where he lived for a time, and of his holding revivals in Richland Springs, Texas where his name is recorded in the Christian Church library as one of the outstanding preachers of the Christian faith.

He, like his neighbors, suffered the general privations of the war and reconstruction. He was able to raise enough food on his farm to feed his family, his store was profitable enough to clothe them, and his knowledge of medicine helped to provide remedies for the ills of his family and neighbors.

His health began to fail about 1890. He wrote his daughter, Mrs. W.T. Willis, in January of 1894 that he had rented a part of the farm. He disposed of his Hopkins County property that year and moved to Kaufman County with his wife, son Lewis Edwin, and daughter Pearl. He and his son established a general store at the crossroads village of Tolosa, Texas. He died in January of 1896.

He initially settled in Section 13 of Township 8, South of Range 26, West. This was on the Muddy fork of the Little Missouri River two miles west of Murfreesboro. Thereafter he moved to Antioch on Wolf Creek joining the families of Samuel Hasley, Elijah Kelley and William Kelley. As with Pike County, Arkansas the early Jackson County, Tennessee records were lost. In a letter written in 1979 by Mrs. Moldon Tayse then County Historian of Jackson County, Tennessee she says: "Our Courthouse burned in 1872 and again in 1927 so we don't have a lot of records, some Chancery court records were in a private office outside the Courthouse, from some of the old Court cases we have gleaned a little ... I'm enclosing a copy of an old deed (of) Abner H. Hancock that I got from an old house. He must have sold this when he was getting ready to go to Arkansas."

Beginning at a buckeye and beech, the north(h) West corner of William Ryleis fifty acre Survey, running thence West sixty-three poles to a sugar tree and two beeches; thence North crossing a branch at thirteen poles, in all forty-five poles to two chestnut oaks and two sugar trees; thence East Eighty-eight & eight-ninths poles to a buck eye and beech; thence South forty-five poles to a beech in the north boundary line of s(ai)d Survey; thence West with said line crossing a branch at fifteen poles, in all twenty-five poles and Eight-ninths poles to the beginning, including the place and spring where the said Sisco now lives. Together with all the ways, woods, water, watercourses, mines,

minerals, hereditments and appurtenances to the s(ai)d land belonging or in any wise appertaining to the only proper use of him the said John Sisco, his heirs &c. forever.

And the said Abner H. Hancock, his heirs &c., doth covenant and agree to and with the said John Sisco, his heirs &c., that he will warrant and defend the aforesaid tract of land and bargained premises, against the lawful claim or demand of all persons whatsoever.

Abner H. Hancock and Lydia Dickson were married in Jackson County, Tennessee by 1830 and their known children were:

Nancy W. Hancock born 1831 in then Hempstead, Pike County, Arkansas (1833); married Benjamin Fredrick Speer about 1849 in Pike County, Arkansas; died 1865 in Jack County, Texas.

Leolan Hancock born June 7, 1839 at Wolf Creek, Missouri Township, Pike County, Arkansas; married Jeraldine Thomas on November 26, 1863 in Collin County, Texas; died August 24, 1887 in Jack County, Texas.

Clement Hancock born 1843 at Wolf Creek, Missouri Township, Pike County, Arkansas; married Nancy E. Hartsfield on October 15, 1863 in Jack County, Texas; died 1865 in Jack County, Texas.

About 1856 Abner H. Hancock moved from Pike County, Arkansas to Jack County, Texas. In January 1858 Abner Handly Hancock was foreman of the first grand jury ever to assemble in Jack County, Texas. On June 25, 1864 Leolan Hancock and Clement Hancock were privates in the Jack County Texas Rangers. On July 4, 1864 Abner Handly Hancock was issued one set of cotton cards by the county court at \$12.50. After this date Abner H. Hancock and his wife ... were murdered and Leolan Hancock ... wounded in their home near Wizard Wells, Texas."

Chapter IV

Civil War and Reconstruction

Jack County, like her neighbors on the Texas frontier, voted to remain in the Union by a vote of seventy-five to fourteen. Slavery was not a deciding question in the county. There were

only nineteen slave owners in the county and of these, thir-teen did not vote at all and five voted to remain in the Union. Jack County records show the names of eleven men who voted for secession plus three others whose names are not recorded ... The fourteen men known to have voted for secession were southerners. By occupation one was a teacher, one a carpenter, one a cattleman and the others farmers. The thirty-four who voted against secession, as recorded by the 1860 census, were also mostly southerners. Overall the groups differed little. It must be assumed that Jack County men voted their own convictions as influenced by their religion and by local newspapers. They obviously felt, like Sam Houston, the Union should be preserved. But after Texas became a part of the Confederacy, most Unionist sentiment was forgotten or went underground. Some violence erupted over the split ... The Hancock family of Sebree Station, stage stop on the Butterfield line between Earhart's Station and Jacksboro, were suspected of being Union sympathizers. Confederate ex-tremists killed the elder Mr. Hancock in Jacksboro and dangerously wounded his son Leallen, who was left for dead in a back street.

The History of Jack County Texas, by The Jack County Genealogical Society, ISBN: 0-88107-043-2. Copyright, Curtis Media Corporation, 1985, page 14. Examination of early Jack County, Texas court records disclose Clement Hancock, son of Abner Handly Hancock, died in 1865. He is the sheriff of Jack County according to the "Dallas Herald" newspaper of Dallas, Texas dated August 24, 1864. Whether his death was related to his activity as sheriff or another cause has not been determined.

LEGAL TERMS

Alias. Term used to indicate another name by which a person is known. Short for "alias dictus" otherwise known as "a.k.a."

When used in connection with a description of a person it indicates that he has used or been known by another name.

Capias. "That you take" the general name for several species of writs, the common characteristic of which is that they require the officer to take the body of the defendant into custody. In English practice, the process on an indictment when the person charged is not in custody, and in cases not otherwise provided for by statute.

Certiorari. To be informed of. A writ of common law origin issued by a superior to an inferior court requiring the latter to produce a certified record of a particular case tried therein. The writ is issued in order that the court issuing the writ may inspect the proceedings and determine whether there have been any irregularities. See also Writ of certiorari.

De bonis non. An abbreviation of "De bonis non administratis."

De bonis non administratis. Of the goods not administered. When an administrator is appointed to succeed another who has left the estate partially unsettled he is said to be granted "administration de bonis non" that is of the goods not already administered.

Et al. An abbreviation for et alii "and others." The singular is "et alius." It may also mean "and another" in the singular.

Facias. That you cause. Occuring in the phrases "scire facias" that you cause to know; "fieri facias" that you case to be made; etc.

Instantanter. Immediately, instantly, forthwith, without delay.

Writ of certiorari. An order by the appellate court which is used when the court has discretion on whether or not to hear an appeal. The lower court is to certify the record and send it up to the higher court which has discretion to hear the appeal. If the writ is denied the court refuses to hear the appeal and in effect the judgement below stands unchanged. See also Cetiorari.

THOMAS MILSON

Thomas Milson was born about 1801 in Pennsylvania. His emergence in Arkansas according to the Clark County, Arkansas court records is by 1827. He entered into Section 5 of Township 9, South of Range 23, West, adjacent Chesley Hughes Rogers. Enumerated as a household of four in the 1830 Clark County, Arkansas census the first tax list for Pike County, Arkansas in 1834 indicates he has a dwelling house, two horses and three cattle. One of his descendants a grandson now deceased re-called "he married a Melson woman." The Dawes Commission records MCR 206 reveal a family relation of Howard Milson to Dr. S.G. Bittick son of Francis Bittick and Mary Ann Melson. Reference *The Gems* 6-66. The name of Thomas Milson's wife in the 1850 Hempstead County, Arkansas census and in subsequent deed records is Rebecca Milson.

The known children of Thomas Milson supported by census and court records include:

Two children (male) age under 5 in the 1830 census. One is identified as William G. Milson age 21 according to the 1850 Hempstead County, Arkansas census.

Samuel Howard Milson born November 1830 in then Clark, Pike County, Arkansas (1833); married first Mary McMahan on January 14, 1855 in Hempstead County, Arkansas; married second Martha C., maiden name unknown, on December 22, 1879 at Gainsville, Texas; died February 22, 1907.

Thomas M. Milson born about 1833 in then Clark, or Pike County, Arkansas; married Ellen A. West on September 23, 1852 in Hempstead County, Arkansas.

Green W. Milson born about 1836 in Missouri Township, Pike County, Arkansas.

Arrissa B. Milson born about 1840 in Missouri Township, Pike County, Arkansas.

Vetumna Jane Milson born about 1842 in Missouri Township, Pike County, Arkansas; married Franklin Coffee Tribble on September 23, 1860 in Hempstead County, Arkansas.

Harrison Clay Milson born about 1845 in Redland Township, Hempstead County, Arkansas; married Martha Lee, maiden name unknown.

Jefferson Taylor Milson born about 1847 in Redland Township, Hempstead County, Arkansas; married Louise Corbet; died August 1884 in Grapevine, Texas.

Rosanna S. Milson born about 1849 in Redland Township, Hempstead County, Arkansas.

Thomas Milson moved from Pike County into Hempstead County, Arkansas about 1845 and settled in Redland Township. Here his death occurred by 1856. He was survived by all of the children mentioned above except Thomas M. Milson prior deceased.

Thomas Milson Family of Arkansas

The earliest verifiable record of my great great grandfather Thomas Milson in Arkansas is found in the Clark County, Arkansas Probate Records (May 1827-October 1838) page 23 when on August 11, 1827 he bought one heifer from the estate of Jacob Wood for \$3.25. In the same document on December 10, 1827 Thomas was appointed an appraiser of the estate of Jacob Wood. The 1829 Sheriff's Census of Clark County, Missouri Township lists Thomas and family as follows: 3 males under 18 years, 1 male 21-44 years, (and) 2 females of 14 years and upward. This census data was taken by Joseph Hardin on March 21, 1829. The 1830 U.S. Census of Arkansas lists Thomas in Clark County, Little Missouri Township as follows: 2 males under 5 years (William G. and another); 1 male age 20-29 years (Thomas was 29); 1 female 15-19 years (his wife). A Clark County, Arkansas auditor's book indicates Thomas Milson served on a grand jury for two days in January, 1833, and again on July 15, 1833. He was paid \$2.00 for the first service and \$1.95 for the second service.

The 1834 and 1835 tax records for Pike County, Arkansas lists his property as follows: (1834) Poll 1, Land (no description), House \$25, Horses 2, Cattle 3; (1835) Poll 1, Land (no description), House \$25, Horses 1, Cattle 3. The first record of an Arkansas land purchase by Thomas Milson is found in *Original Land Purchases*, Southwest Arkansas, Tract Book 1, page 173. In 1836 he purchased land in Township 9, South of Range 23, West. The Pike County, Arkansas tax records for 1836 through 1844 (no listings 1837, 1838, 1841) for Thomas Milson: (1836) 1 Poll, Land 40 acres, House \$75, Horses 1, Cattle 6; (1839) Poll 1, Land 40 acres; (1840) Poll 1; (1842) Poll 1, Land 80 acres; (1843) Poll 1, Land 80 acres; (1844) Poll 1, Land 80 acres. An intriguing side note: the 1842 tax records indicates the land Thomas Milson owned was originally owned by James G. Melson. The Melsons lived close to Thomas Milson's family. Other ties to the Melson family will be discussed later.

On motion of John Wood administrator of the estate of Jacob Wood, deceased, It is ordered that Thomas Melson be and he is hereby appointed an appraiser (in the room of Preston Mathews who has removed from Said County) to act in con-junction with James Ward and Jacob Brinley in appraising the residue of the Slaves if any and personal estate of which the said Jacob Wood, deceased, died possessed.

Thomas Milson's family appears in the 1840 U.S. census, Pike County, Missouri Township as follows: 3 males under 5 years (Green W. and two others); 3 males 5-9 years (Thomas M., Samuel H., and another); 2 males 10-14 years (William G. and another first identified on the 1830 census); 1 male 20-29 (an error Thomas was 39); 1 female under 5 years (Ariisa B.); (and) 1 female 20-29 (his wife). In 1845 Thomas Milson is listed in the Clark County, Arkansas tax records and the next records of him are the 1848-1850 Hempstead County, Arkansas tax records. His first land holdings during this period is 40 acres in 1850.

The 1850 U.S. census provided the first insight into the specific family members names and the link Thomas Milson was my ancestor. The 1850 census was the first time names of family members were required along with age, occupation and birthplace. In 1850 Thomas Milson and family was living in Hempstead County, Arkansas. The census taken on December 6, 1850 records the following:

This data verifies Thomas Milson was my great great grandfather the father of Jefferson Taylor Milson and that Thomas was born about 1801 in Pennsylvania. Based on the 1830 census it can be assumed that his wife would be 35 to 39 years old in 1850. Rebecca's age listed as 28 (a second wife?) or could her age have been incorrectly recorded by the enumerator? The Hempstead County, Arkansas Deed Book M, page 357, has the following action: On February 4, 1856 the mortgage on land described in Deed Book K, page 49, was filed again with this addition: "Rebecca M. Milson wife of the late Thomas Milson in consideration of the sum of one dollar to me in hand paid by David Block and Virginia Block ... hereby relinquish to the said David Block and Virginia Block all my rights, title,

interest, or claim in land described above." If her age was recorded correctly (in the census) she was not his first wife. This document also reveals Thomas Milson died prior to February 4, 1856.

An interesting insight can be gained about the Thomas Milson family in the 1850's from existing deed records of Hempstead County, Arkansas: February 1, 1851. Thomas Milson mortgaged to Philip T. Graves for \$50 a tract of land: SE3 NE3, Section 36, Township 9 South of Range 24 West. P.T. Graves acknowledged release on January 31, 1852. Deed Book I, page 302.

January 31, 1852. Thomas Milson mortgaged to David Block and Virginia Block (same tract) for \$287.05, 10% interest, payable in 12 months. Witnesses: Henry Block, M.W. Edwards. Deed Book K, page 49.

February 4, 1856. The mortgage on the same land was filed again with the addition of this statement: "Rebecca (spelled Rebecah elsewhere in the same record) M. Milson wife of the late Thomas Milson in consideration of of the sum of one dollar to me in hand paid by David Block and Virginia Block ... hereby relinquish to said David Block and Virginia Block all of my rights, title, interest or claim in lands described above." Deed Book M, page 357.

June 1857. David and Virginia Block complained against William G. Milson, Samuel H. Milson, Harrison C. Milson, Jefferson T. Milson, Belum-ney G. (Vetumna Jane) Milson, Rosanna S. Milson, ... and E.A. Milson. The court ordered foreclosure of a mortgage executed by Thomas Milson and Rebecca M. Milson, his wife, to David and Virginia Block on land described in Deed Book I, page 302, 40 acres. Secured payments of \$287.05, 10% interest debt, and \$440.25 unpaid and uncollected. Sheriff ordered sale of land, Thomas Milson and Rebecca M. Milson having departed this life without leaving estate, from which owed sum could be paid. Chancery Book C, page 220.

May 17, 1858. Sheriff's Deed. W.G. Milson, Sam H. Milson, Harrison C. Milson, Jefferson T. Milson, B.G. Milson, R.S. Milson, E.A. Milson granted to David and Virginia Block land in the SE quarter of

the NE quarter, Section 36, Township 9, South of Range 24, West. Deed Book O, page 228.

May 22, 1858. Sheriff's Deed. Forclosure ordered by the Chancery Court in June 1857 of mortgage as well as \$540.25 cost and \$12.25 taxes. The land was sold to satisfy the decree on June 26, 1857 to David and Virginia Block, highest bidders, for \$5.

From these legal records the Thomas Milson family was struggling to maintain their farm. It is also evident Thomas Milson died between January 31, 1852 and February 4, 1856. Rebecca M. Milson, his wife, died between February 4, 1856 and June 1857.

Letter: John W. White to C.C. Hughes, Rock Creek, Pike County, Arkansas, May 21, 1897

The following letter was abstracted from a photocopy supplied by Max Duren, 125 Highland Dr., Ennis, TX 75119. It was sent by John M. White and his wife Leemanda Hughes White of old Rock Creek near Glenwood in Pike County Arkansas to Leemanda's brother, C.C. Hughes, who lived at Petty in Sevier County, Arkansas. It is dated May 21, 1897. Since the photocopy is of very poor quality and somewhat incomplete, I have added some words and modern spelling to make it more understandable.

John M. White was born in Upson County, Georgia on May 24, 1833. He married Leemanda Hughes about 1860. Both Mr. White and his wife are buried in the Ebenezer Cemetery located on Rock Creek Road just west of Glenwood. Mr. White died in 1903. They became the parents of the following children: William D., Adaline D., Lucinda, Marion F., James B., John L. and Dora. Adaline D. White married Angus McMillan brother of my ancestor Elizabeth Jane McMillan Baker. For more information on this family see Goodspeed's Southern Arkansas page 346, the 1880 U.S. Census of Clark Township, Pike County, Arkansas page

452A, and Arkadelphia Southern Standard, July 9, 1903, page 2 column 1. The letter:

Page 1. "Our Brother & sister it is through (the) mercies of god that we are (permitted) to answer your just received sad news to us. (The Hughes's daughter, Ethel, had just died). But let us rejoice (to)gether in the little (?) hope of eternal life beyond this veil. 'Tis god that gives & god that takes a way & we are made to rejoice to see in your (letter) to us that Ethel went in peace & love to join the throng that goes before. We have one little sweet baby that (is gone) there which I often feel like I (go) ere soon to meet. O' what a joy there is in heaven. No one on Earth can tell - it does not yet appear to us what we will be. Though one thing we (do know) that we shall see him, Jesus. We shall see him as he is & be like him."

Page 2. "The 24th of this month I will be 64 years old. Just past month it seemed I was (?). You see we are getting old. Been hard workers all thru life. So (we know) that our lives here is short & all I (want) is to go with the same smile to bid (fare)-well to Earth's remorse (?). (Lee)Manda (my wife) (has become) feeble in deed. We live in the house with Lee & Bettie. J(ames) B. and Lee is running (a) business together at the Creek (Rock Creek) and making a good living. (The money) Lee owes the Baker (Brothers is) near all paid for. He is going well. I get any & every thing for (my wife that) she needs or wants that would make her comfortable in life(:) a good buggy to carry her when (she is) able to go which I crave & to be able to do in life (more for her). I stay in the store near all the time and it suits me fine - did Mr. Brown your neighbor get (his) stolen mule & (catch the) man. I sold him some tobacco (for) his trip. Let us hear (from you) again. J(ohn) M. and Lemanda White."

It is the sincere hope of the author that this family record may be found of value to subsequent family historians who may be able to build a vastly better history than this one. This earnest work of compilation is ended September 1950 after many years of collaboration with relatives for records (and) has been brought to my kindred with love and adoration and the joy of pursuit: it is presented to all of my relatives and friends believing that in putting into permanent form the names of hundreds of heretofore "unsung heroes and heroines" (that) have unselfishly served unborn generations who through

the centuries will have cause "to rise up and call them blessed."

First Family Record of Ancestors

Thomas Samuel Welch

Thomas Samuel Welch was born May 11, 1749 in Lancaster County, Pennsylvania and died March 2, 1846 age 97 years. His wife Mary Ann (maiden name not indicated) died February 11, 1839. Their children born in North Carolina were: Archibald Welch born 1770, John Isaac Welch born 1773, James Welch, Joseph Welch, and George Welch born 1779. In the D.A.R.L.C. (Daughters of the American Revolution Library Collection) there is a record of Archibald Welch having a lawsuit in Gainesboro, Jackson County, Tennessee and there is a statement in the same record that John Isaac Welch had brothers and sisters and that (his brother) George Welch married Elizabeth (?) and that his will is on record at Sparta, White County, Tennessee and the will was proved in 1853 by James and Mathias Welch.

John Isaac Welch

John Isaac Welch born 1773 in North Carolina, wife's name not listed, but she died early. Children: Isaac Welch born 1792.

Isaac Welch

Isaac Welch born 1792 in North Carolina. Wife Judith (maiden name not indicated) born in North Carolina. Children: Thomas Franklin Welch; Samuel Welch; John Isaac Welch; William W. Welch born November 17, 1827 died March 16, 1863; Polly Welch married Jesse Reagon on December 20, 1838 in Hardeman County, Tennessee; Elizabeth Welch married Mack W. Marris on December 17, 1842 in Hardeman County, Tennessee; George W. Welch born 1825, Overton County, Tennessee married Mary Pauline Ward on January 6, 1844 at Bolivar, Hardeman County, Tennessee; and Francis M. Welch married Hannah I. Mayfield on May 1850 at Bolivar, Hardeman County, Tennessee.

Thomas Franklin Welch

Elder Thomas Franklin Welch born April 27, 1812 in Overton County, Tennessee died August 22, 1871 and was buried at Glenwood, Arkansas. He married February 28, 1831 Elizabeth Oliver born February 12, 1810 in Georgia died July 20, 1883 and was buried at Glenwood, Arkansas. Children: Nancy Welch born December 11, 1831; John Welch born September 12, 1833; Polly Welch born June 28, 1836; George W. Welch born October 10, 1837; Sarah E. (Betty) Welch born May 17, 1840; Thomas Jefferson Welch born January 9, 1843; James Pike Welch born September 19, 1845; Isaac Franklin Welch born December 13, 1850; and William Wallace (Billie) Welch born September 30, 1853.

Thomas Franklin Welch was buried on his home place at Glenwood, Arkansas. He was a Baptist preacher in Tennessee and Arkansas and he and his five preacher sons organized most all of the early Baptist churches in Southwest Arkansas, many

are still in existence. He was a Royal Arch Mason, Moderator of the Caddo River Association in Montgomery County, Arkansas for seventeen years 1854-1871.

A Short History of Thomas Franklin Welch
by his son Isaac F. Welch, 1912

My father, Elder Thomas Franklin Welch was born of Irish parentage in middle Overton County, Tennessee (on) April 27, 1812. In 1830 he was united in marriage to Elizabeth Oliver, four or five years later professing faith in Christ and uniting with the Missionary Baptist Church. He immediately entered the ministry in answer to a call to preach the glorious gospel of Jesus Christ.

In the fall of 1853 he and a number of families loaded their covered wagons and left Hardeman County, Tennessee for Waco, Texas. On their long journey they camped on Saturday night on Collier's Creek (in) Montgomery County, Arkansas to rest on Sunday which was their custom on the entire trip. Some of the citizens in that community, learning that he was a preacher, persuaded him to abandon his long trip to Waco, and stop there. He was told that there was a fine farm for sale at the mouth of the South Fork just below the Gap owned by James Chaney. Early Monday morning he asked the crowd to remain in camp and he would go over and look at the place but with very little thought of stopping in that country. After looking over the farm, however, and having been influenced by the fact that there were no Baptist preachers in all that country and by the persuasion of his new friends, he bought the place. I think he sold this place in 1859 to Baalam Strawn who about this time the Caddo Gap Mills from his brother Judge Fielding Strawn and W.M. Sanders. My father then bought the farm just below Glenwood where he and mother are buried.

My father's time was fully occupied as pastor of various churches from the time he arrived in that country until his death August 22, 1871. Covering a wide territory his work extended from Mt. Ida in Montgomery County to Alpine to Clark County and from Deroach, Hot Spring County to Nashville in Howard County. Since he never received a full temporal support from his churches, he farmed in connection with pastoral work. I believe he was one of the most self-sacrificing, consecrated and devoted men I have ever known. It has been said, "that the noblest work of God was when he made an honest man." If this be true, my father's creation was a noble work. I say this because I had the very best opportunity to note his life from day to day for many years and those who would have delighted to speak of his noble qualities have crossed over the river there being so few left who knew him intimately.

Having served as pastor there for seventeen years (1854-1871) some of the best work of his life was doubtless in his home church, old Bethel. Eternity alone can reveal the results of his labors at this place.

I was at the old home place last December (1911) and as I sat in the home of Mr. Batreal, whose house covers the spot where our old house once stood and the writer spent the greater part of his boyhood days, memory's pages began to unfold and a scene passed in review:

I pictured my father sitting on the left side of the old fireplace as one entered the east room from the hall, a great quantity of split pine knots behind his chair. As he sat with his back to the wall, so the light from the fireplace would shine on the pages of the book he read, he occasionally would throw on another pine knot as it was needed. His library was easy to reach to his right. Next to him, the companion of his life, my mother, sat and in a semi-circle around that old hearth-stone were their children. The book my father held was the Bible. Every member of the family also held a copy of that precious volume, each reading a verse around until the chapter was read. Often my father would ask questions or make a short comment; a hymn was sung, and prayer was led by father or one of the boys, O precious times!

As I sat there and thought of those precious seasons forever gone, I wondered that I had not been a better man, with such a father, such a Godly praying mother, and such sacred surroundings. Allow me to write it down: my honest conviction is that such earnest service and efforts will always be rewarded.

Dear David:

I have recently come across five old school records sheets for the Old Japany School. Thought you might like to know what I know about it. I don't know when the school was started, but I do know my father and some of my aunts attended the school for several years. It was located south of Murfreesboro, about 3.5 miles. It was on the left hand side of the road at the point where you turn left to go to my birthplace and just across the highway (which is Highway 301) from the "Terrell Access to the Little Missouri River" and the road to Roy. There still stands the old original Well House for the school. It was painted white and is still so. The Well is bricked and still has water in it. The school was originally a one room building and later expanded to two rooms since so many children started attending school there. My dad said at one time there was at least eighty children going there. They came from Murfreesboro, Kimberly, Roy, Boto and a few from Billstown.

When they lived in Kimberly they would walk each day down to the Japany school. Aunt Ott which is what we call her said she remembers helping carry the bricks to build to brick the well. She told me who the name was that did the well and I

have it written down some where, but can't find it. All three of them remember the teachers that taught them at the time. They were O.A. Featherston, Mr. Holtz and Mr. Howard A. Dawson. They said they were all very good teachers, but Uncle Claud said Mr. Featherston scared him too much and couldn't learn anything from him. He said he would study real hard in hopes of impressing Mr. Featherston, but the next day of school when he was called to give an answer, he was so scared that he would forget everything he had studied the night before. They all said Mr. Holtz was a German and they all liked him very much. He was kind and gentle, but yet firm and demanded the students gave him full attention when class was in session. My dad said one day some of the boys on one of the benches kept talking in class and finally Mr. Holtz walked up to the bench and kicked it over. 'Course the boys didn't talk in class anymore he said.

As a young boy myself I remember seeing some of the old logs that the buildings were on. I don't know if they can still be seen since the land has been clear cut and has grown up very badly. I am now in process of trying to obtain from the owners of the land permission to restore the Well House. It is in very good condition and won't take to much to do it. I very much want to do this since it is a part of Pike County History.

headstones plus many hours of keeping it mowed. The fence is already going to have to be changed to barbed wire because cattle keep knocking it down and get into the cemetery. They have already knocked over some of the stones and broken them.

If there is anyone who would like to make a donation to the cemetery they may do so at the Pike County Bank. Make deposits out to "Kimberly Cemetery Fund". This fund will only be used for the mowing of the cemetery when I become unable to take care of it. All donations are deeply appreciated.

Wouldn't it be great if everyone would become more interested in restoring and preserving our history? It is such a shame that only a few are willing to do so.

These indexes are arranged two ways - statewide and in regional volumes. This makes the information more affordable and tailored to your needs. The data are the same in the statewide and regional volumes, only the arrangement and selection are different. See "How to Order" after the book descriptions.
